Processing of Applications:

Procedures

- Processing of the applications will be started from May 2024.
- Applications will be reviewed by a jury comprised of eminent experts in the Indian Energy Sector.
- Clarifications/Validations by the jury could be part of the review process.
- The results of the SEEM Awards 2023 will be published during August 2024.
- The Awards ceremony will be held in New Delhi during September 2024.
